92nd Congress, Sweden

Professor Jan Huggare, at the recent Council meeting, reported a surplus of approximately €82,500, which has been allocated for future research grants.

This session is open to all congress delegates.

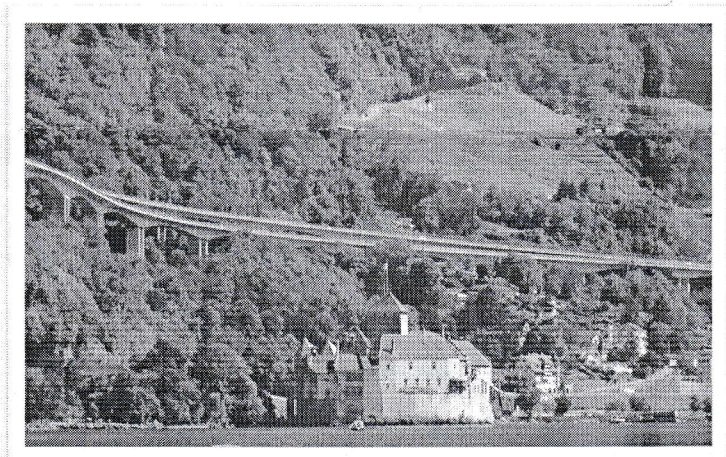
Honorary Treasurer
