European Board of Orthodontists (EBO)

Twenty nine candidates have applied to sit the EBO examination which will take place during the annual congress in Nice.

NEBEOB and Teachers' Forum

The 12th Annual Meeting of NEBEOB will take place on Tuesday, the 18th June.

The topic for the Teachers' Forum, which will be held on the same day, will be 'Communication between postgraduate schools in Europe'. Timo Peltomäki and David Rice will give the lecture and lead the discussion. Working groups will be formed during the meeting. The aim is to develop a basis for better collaboration and communication between different schools.

94th EOS Congress

Since there was a large surplus from the Congress in Edinburgh in 2018, Council agreed that this money should be used to purchase a rental property and to generate

income for the Society. A flat was purchased in the same building where the office of

the EOS is located, which has already been sublet.

The 94th Congress is one of three events shortlisted for the newly introduced Scottish Thistle Awards that promote tourism in Edinburgh. The judges were impressed by the

level of collaboration, logistical prowess and client feedback from hosting this highly prestigious European Congress.

Forthcoming Congresses

Only one application was received from Finn Geoghegan to host the congress in 2025 so no ballot will take place, but the appointment will be formally reported and ratified at the Business Meeting in June.

Position of Honorary Secretary

There was one application for the Honorary Secretary's post to start in June 2020 and this was from Dirk Bister. Council were supportive of his potential and this will also be ratified at the Business Meeting.

Grants

There were 12 applications for EOS grants this year. All applications have been sent to independent referees and, when the reports have been received, they will be considered by the Research Committee.

W J B Houston Research Scholarship

One application has been received for this award which is under consideration.

Distinguished Teacher Lecture

Timo Peltomäki will give the second of his lectures on the top of 'Craniofacial and occlusal growth and development - clinical implications' in Stockholm, Sweden on the 19th/20th September 2019.

The 2020 Distinguished Teacher is Ewa Czochrowska. Her lectures on 'How to successfully apply tooth transplantation in everyday orthodontic practice' will take place in Sofia, Bulgaria and Barcelona, Spain.
