EOS Congress 2022

It is planned to hold the postponed Congress in Cyprus from the 30th May to the 3rd June 2022, but further information will be posted on the EOS website in due course.

Future Congresses

The venues for future congresses have been identified until 2027. However, the pandemic has exposed the very fragile state of the past organisation of the EOS. Currently, whilst we have the webinar series for those unable to attend the congress, we are investigating how to secure future conferences. Those wishing to arrange congresses after 2027 will be considered if they are able to provide financial guarantee to support the application. An advert to hold the congress in 2028 will be published in the November issue of the European Journal of Orthodontics and on the EOS website.

Distinguished Teacher Lectures

The first of the webinars arranged by the EOS took place on the 5th February. The 2020 Distinguished Teacher Lecture, which was free for postgraduates, was given by Ewa Czochrowska on "Autotransplantation of developing teeth" and was attended by 459 registrants from 35 countries. The feedback received was highly positive.



The Distinguished Teacher for 2022 is Björn Ludwig who will speak on "From enthusiasm, to frustration or back to the future – temporary anchorage devices (TADs) in the digital age". It is anticipated that this lecture, that will be free for postgraduates, will be of interest to a large number of students and early registration is recommended. Priority will be given to postgraduates who are EOS members.
