The Distinguished Teacher for 2023 is Ambra Michelotti. Information concerning the lecture, which is free for postgraduate students, will be published online in the next few weeks.

EOS Research Grants

Grants were awarded in 2022 to Erwin Jonke of the University of Vienna (Austria) and Edwin Ongkosuwito/von den Hoff of Radboud UMC (Netherlands), to undertake research on 'Immune cell type composition in human saliva during multi-bracket therapy: a pilot prospective study', and 'Exosomes from oral stem cells to improve cleft palate repair', respectively.

Grants (up to £20,000) will be available in 2023, and members are encouraged to prepare applications. **The deadline for submissions will be 1 January 2023.**

Lingual Award

Two applications have been received for this prestigious award, up to the value of £50,000. Following discussion with the applicants, one full submission has been received at the time of going to print.

This submission is under consideration and the outcome will be announced in early 2023.

Membership Renewal

Members are reminded that all subscriptions are to be renewed online – you will receive an email 30 days before your membership expiry date reminding you to renew and giving you instructions on what to do. In advance of this, we kindly ask that you **make sure your email address is up to date on the website**, as the annual subscription reminder will only be sent via a computer-generated email.

Please note if the subscription is not paid on time, membership will be automatically suspended and an administration fee of £20 will be payable in addition to the subscription.

Increase in Membership Fee

It has been agreed by the EOS Council that, whilst the postgraduate fee remains at the level of £30, the membership rate for full and associate members will rise to £70.00 – this will come into effect immediately.

Honorary Treasurer Position

Following the consideration of the roles of the honorary treasurer, and the legal complexities created during the recent pandemic, the post is being restructured. It is clear that the individual has to have a sound grounding in the legal complexities of charity management as well as the very strict administrative governance, so as not to compromise the trustees of the charity. In addition, the time commitment of 1.5 days a week would impact on trustees whose lives are already busy.

This role is now being reviewed to be a non-trustee professional role.

2028 Congress in Italy

At the Council meeting in Cyprus, proposals to host the 2028 congress were considered and, following receipt of all necessary documents, Italy was chosen as the 2028 host under the presidency of Mauro Cozzani. Further details will be released in 2023.

President for 2029 – Call for Applications

Applications are invited for the position of President for 2029 from active members in European Countries.

All proposals must be accompanied by letters of support from four active members of the Society, one from a member in the nominee's own Country and three from active members in the three different European Countries. The nomination must be signed by the nominee and include a brief Curriculum Vitae.

In the event of there being more than one application a ballot will be held.

In light of recent financial issues, those wishing to stand for President and organise a congress on behalf of the EOS must provide a financial bond of €50,000. This will be returned following a successful congress.

The closing date for all applications is the 31 December 2022.

Online Access to the EJO from January 2023

As of 1 January 2023, the European Journal of Orthodontics (EJO) will become an online-only journal.

There will be **a new way to access the journal**: you will need to log into the membership area within the EOS website (see screenshot below). When logged in please click on the journals button which will take you to the EJO website and journals; no further verification other than your membership number and email will be required.
